The legal representative of the legal entity identified below, which was contracted to provide stand assembly and dismantling services for one of the exhibitors at the Expo Revestir 2026 trade show, to be held from March 9th to March 13th, 2026, I STATE and ACCEPT, under penalty of law, by virtue of the decision rendered on 02/02/2022, by the Labor Prosecutor Dr. Mariana Flesch Fortes, regarding the Conduct Adjustment Agreement (TAC) No. 276/2020 (referring to Civil Inquiry No. 1775.2019.02.000/1), signed between the BRAZILIAN ASSOCIATION OF MANUFACTURERS OF CERAMIC TILES, SANITARY WARE AND RELATED PRODUCTS – ANFACER and the LABOR PROSECUTION OFFICE – REGIONAL LABOR PROSECUTOR'S OFFICE OF THE 2ND REGION – SP, whose content can be accessed at website https://www.exporevestir.com.br/, in which it was determined that proof of effective training of the assembly and dismantling workers of the aforementioned event regarding the risks involved in the execution of the services that:

- is aware that it is mandatory for all workers who will be involved in the assembly and dismantling of stands at Expo Revestir 2026 to present the NR 18 training certificate – Working Conditions and Environment in the Construction Industry.
- is aware that each exhibitor must have, in their assembly team, at least one worker duly certified in NR 10 Safety
 in Electrical Installations and Electrical Services and NR 35 Work at Height, in addition to complying with the
 provisions of the previous item.
- 3. Please be aware that proof of the required certificates must be submitted to the event organizer in advance, by February 13, 2026.
 - Workers who do not present the required certificates must watch the mandatory instructional video, lasting approximately 45 minutes, in the pavilion before starting their activities. Entry to the assembly area will not be permitted without completing this step.
- 4. Please be aware that the trade show organizer, as well as inspectors from the Ministry of Labor and representatives from the Labor Prosecution Office, may, at any time, request proof of certificates or participation in the instructional video. If the lack of proof is verified, the worker will be prevented from accessing the assembly or dismantling area until the issue is properly resolved.
- 5. is aware that personal identification, via a badge that must be worn at all times, will be required of all workers throughout the entire period of stand assembly and dismantling periods; and
- 6. Finally, is aware that, as stipulated in the Adhesion Contract and Participation in the International Trade Show of Coatings and Finishing Solutions Expo Revestir 2026, executed with the Exhibitor, Failure to comply with current occupational safety and health regulations during the assembly or dismantling of the event, as well as the provisions of the aforementioned TAC (Conduct Adjustment Agreement), will result in the motion and prohibition of the work by the event organizer or the Public Authorities. Furthermore, considering the seriousness of the matter, the Adhesion Contract and Participation in the International Trade Show of Coatings and Finishing Solutions Expo Revestir 2026, entered into with the aforementioned Exhibitor/Stand Constructor, may be immediately terminated, and the Exhibitor/Stand Constructor will be responsible for the payment of all contractual fines or penalties imposed to ANFACER without prejudice to the penalties provided for in article 299 of the Penal Code.
